The Indebtedness has been incurred or will be incurred in the future. The Indebtedness shall include, without limitation, all interest, fees, charges, expenses, costs of enforcement or collection, and reasonable attorneys' fees.

Guarantor agrees that You may at any time, without notice or demand of any kind and with impairing or releasing Guarantor's obligations hereunder, change the Customer's terms of sale, credit limit, interest rate and time for repayment, and grant any extension, compromise, settlement, release or discharge, in whole or in part, to Customer or to anyone liable with Customer. No delay, inaction or leniency by you to the Customer or to any Guarantor, if there is more than one Guarantor, shall affect the liability of the Guarantor for the Indebtedness. The Guarantor waives demand, presentment, protest and any other notice with respect to any action you take with respect to the Indebtedness. You are not required to enforce any remedies against the Customer or any other party liable to you on account of the Indebtedness.

This is a continuing and unconditional guarantee of payment (not of collection) and is effective until you receive written notice from Guarantor that Guarantor is to be released from liability for any future indebtedness incurred by the Customer after you receive this written notice. This Guarantee contains the entire agreement between you and the Guarantor and cannot be changed or terminated orally. Guarantor agrees that any process served on Guarantor shall be sufficient if mailed to the address listed below or to Guarantor's residence by certified mail, return receipt requested.
